RE: Invitation to Statewide Efforts

Dear [Prolife Leader],

We are reaching out to invite you to be a part of statewide efforts to REPEAL 79 to get abortion out of our state Constitution. The abortion amendment currently prevents protecting our youngest and most vulnerable children all nine months of pregnancy at taxpayers' expense. The Repeal of 79 will remove the abortion amendment from our state Constitution.

We have recently experienced **an important win** by gaining title to collect signatures. This past year, we have worked diligently to place an amendment before the people of Colorado for the 2026 ballot. At the last possible moment, the state granted us the opportunity to collect signatures—an opportunity we do not take for granted and wish to use to its fullest advantage.

We would like to invite you and your organization to join the efforts and educational opportunities available to you in Colorado through the urgency and timeliness this initiative provides to further the cause to protect preborn children in Colorado.

**For our next win**, we would like to provide significant push-back to the abortion death industry by gathering the necessary signatures for this repeal to appear on the ballot. Appearing on the ballot will speak loudly from the prolife movement that abortion is not a “right”, and the prolife people of Colorado do not approve of preborn child abuse in our state Constitution.

**To get on the ballot will be a significant win.** It will draw national and state attention to the plight of the preborn child and our responsibility as individuals before God and others to love them and to treat preborn children as we ourselves would like to be treated.

This is an opportunity for the prolife community to make **an urgent call to action** and for Christians to preach repentance for the innocent bloodshed and unjust laws in our state.

With faith that **with God all things are possible**, we are providing Christians and prolife activists the opportunity for Colorado citizens to let your voices be heard – to speak loudly, educate boldly, and speak for those who have **no voice but ours**.

We are in need of a minimum of 125,000 signatures across the state with the signatures of 2% of registered voters from each of the 35 Senate Districts. Our goal is 125 filled petition packets from each of the thirty-five (35) Senate Districts across Colorado. Each petition packet has space for forty (40) signatures. Our last deadline to return petitions is July 27, 2026. If passed in November, the repeal would go into effect December 25, 2026.

If each of us contributes whatever the Lord has entrusted to us – volunteers, social media following, a platform to speak, finances, ability to get the word out and encourage participation – we can each use our

various skills, talents, and unique perspective and audiences for the greater goal of removing abortion from our state Constitution.

We are asking for all hands-on-deck to **overwhelm the state with our voices for life!** There are many ways you and your organization may wish to participate to make a difference in our state. Please let us know how you would like to help with and contribute to these historic and monumental prolife efforts.

1. **Prayer ministry** - pray in faith for the success of REPEAL 79 in Colorado.
2. **Educational efforts** - educate Colorado voters about the humanity of preborn children, the cruel torture and child abuse of chemical and surgical abortions, the emotional and physical harm to women when causing mothers to abort their children, and the resources available to pregnant mothers through pregnancy resource centers and modern adoption. Please let us know if you would be willing to use any of your platforms to help educate voters through: social media, television, newspaper ads, Letters to the Editor, door-to-door, college campuses, churches, flyers, signs, billboards, radio, in-person presentations, panel discussions, debate, podcast, media interviews, events, or other creative educational efforts.
3. **Volunteerism** - encourage followers to volunteer to help collect signatures. Help organize volunteers in a particular area of the state, or strategize a particular Senate District. (This letter is reaching more than 50 prolife organizations with a presence in Colorado, and we have only 35 Senate Districts to organize.) Churches may also organize their congregational efforts to cover their community or county.
4. **Funds** – help fund paid petitioners for those last hard-to-get Senate Districts.
5. **Video or Quote** of endorsement.

We are thankful for the many prolife and Christian organizations already supporting these efforts through generous donations and volunteers. We welcome all persons of faith and goodwill to assist in efforts to gather voter signatures to put before voters in November a repeal of the so-called “right” to abortion. Those voting to Repeal 79 can also vote to protect children in sports and from sterilization surgeries as teenagers. This could be a sweeping victory for children in our state.

Every time *life* has been on the ballot in Colorado, abortions have decreased by 10% the following three years (with the exception of the late-term abortion limit), and voters have increasingly voted for life. This is a \$2 per person expense for at least forty conversations with neighbors and friends about the importance of protecting the lives of preborn children multiplied five thousand times across the state.

Please let us know how you and your organization are willing and able to help these prolife efforts, and please encourage your members to sign and circulate petitions to get abortion out of our state Constitution.
