

FACT SHEET: PROTECTIONS OF LIVING CHILDREN INITIATIVE

Who We Are: We're a grassroots movement of the body of Christ putting forward the 1st Life Initiative on the Colorado ballot since the overturn of Roe.

What Does This Initiative Do? This initiative protects all living children from intentional mutilation and death beginning at conception until adulthood.

Why an Initiative? This initiative does not need the legislature or governor's signature just "We the People" to vote to overturn current law that allows children to be tortured to death all nine months of pregnancy through birth.

Why are you doing this? We are motivated by love to apply the US Constitution that protects our right to live to our Posterity, which are those who come after us.

Why a Law? The purpose of law is to protect our neighbors from being harmed and harming others. Children need protections from being tortured to death before they can have a birthday.

What About Women? Abortion is violence against women, traumatizing mothers. 81% of mothers who experience an elective termination of pregnancy experience rage, depression, anxiety, suicidal tendencies, and drug and alcohol addiction.

Why from conception? It's a biological fact that children are fully human, alive, and growing from Day 1 when our unique DNA forms in our first cell that will replicate in every cell of our body.

What are you asking people to do? We are asking people to pray, educate those around you on the humanity of preborn children (and the violence of abortion and what God says about just law), and help gather in-person signatures on the Official Paper Petition by March 31st. Then Vote Life!

How is signature gathering going? We are currently collecting signatures and with enough signatures we expect to be on the ballot.

What about the Catholic bishops? This initiative agrees 100% with the Catholic faith.

What about the life of the mother? Mothers are already protected; we're asking that children are also protected.

What about the health of a mother? Abortion is NOT healthcare. Abortion causes death. It is not necessary to intentionally take the life of a child. Childbirth and c-section where the child has a chance to live are also safer for the mother than intentionally poisoning or dismembering a child through abortion. Abortion puts the mother into preterm labor or stretches her cervix unnaturally.

What about rape and incest? Perpetrators should be held accountable. Further violating a mother's body and taking the life of her child does not bring a perpetrator to justice. We don't punish children for the crimes of their parents.

What about miscarriage? The initiative applies to Living children. If there isn't a living child, then this initiative does not apply.

Is this the right time? As Martin Luther King said, “it’s always the right time to do the right thing.” The lives of actual children hang in the balance.

What if both initiatives get on the ballot? Colorado voters will have a clear choice between life and death.

What would you say to a woman’s reproductive health or bodily autonomy? A woman should always have a choice ‘where, when, and with whom’ she engages in activity that could lead to the creation of a child. Once a child is created, she is a mother responsible for the care, nurture, and protection of her children.

What’s different about this initiative? With enough signatures, this will be the first Life Initiative on the Colorado ballot since the overturn of Roe. It will educate every Colorado voter on the humanity of preborn children. We are fasting and praying to break child sacrifice off Colorado.

Can a woman be prosecuted? The Colorado Life Initiative would make it illegal for anyone to intentionally mutilate or take the life of a child. The law applies to everyone. Regardless of gender, no one is exempt from obeying the law. Woman or man, it will be illegal to intentionally mutilate or take the life of a child beginning at conception until adulthood. Anyone doing so will be intentionally breaking the law. (If mothers can continue to take the lives of their children, abortion remains legal. If women are exempt from the law, abortion clinics remain open.)
